Office Order

Firm D.R. Paint And Chemicals has rate contract no 20210000601 (29-Jan-2021 to 28-Jan-2022) with UPMSCL for the supply of drug "Alcohol Based Hand Sanitizer". Firm has supplied Drug "Alcohol Based Hand Sanitizer" batch no RO/0921/003, RO/0921/006, RO/0921/007, RO/0921/008, RO/0921/010, RO/0921/013, RO/0921/022 and RO/0921/025 to various District Drug warehouse of Uttar Pradesh Medical Supplies Corporation Ltd. against Purchase order no. UP/UP/HQ/21/791/1 (10282105014), dated 13-09-2021.

Sample of Drug "Alcohol Based Hand Sanitizer batch no RO/0921/003" RO/0921/006, RO/0921/007, RO/0921/008, RO/0921/010" RO/0921/013, RO/0921/022, RO/0921/025, were sent to UPMSCL empanelled laboratories. Finally Above eight drug batches were declared "Not Of Standard Quality" after result from UPMSCL Empanelled laboratories.

A notice (ref no- UPMSCL/MD/QC/2022/200) to Firm D.R. Paint And Chemicals was sent on dated 09.05.2022 for supplying "Not of Standard Quality drug" Alcohol Based Hand Sanitizer batch no RO/0921/006 and RO/0921/010" to different District Drug warehouse of Uttar Pradesh Medical Supplies Corporation Ltd. Response (Letter dated 13.5.2022) from firm was obtained on dated 21.05.2022.

Another notice (Ref no.- UPMSCL/MD/QC/2022/608) to Firm D.R. Paint And Chemicals was sent on dated 08.07.2022 for supplying "Not of Standard Quality drug" Alcohol Based Hand Sanitizer batch no. RO/0921/003, RO/0921/007, RO/0921/008, RO/0921/013, RO/0921/022 and RO/0921/025. Response from firm was obtained on dated 12.07.2022.

In the response dated 13.5.2022 and 12.07.2022, Firm has mentioned that as per "National Center for Biotechnology Information" Chlorhexidine Gluconate solution is not an essential component in Alcohol Based Hand Sanitizer. But Firm has supplied Drug Alcohol Based Sanitizer in which Chlorhexidine Gluconate is one of the component and same is mentioned on label of supplied Drug Alcohol Based Hand Sanitizer and on that behalf testing was done by UPMSCL empanelled Analytical laboratories.

Response provided by Firm dated 13.05.2022 and 12.07.2022 were taken in to consideration but not found satisfactory. It was clearly mentioned on the Purchase order no. UP/UP/HQ/21/791/1 (10282105014), dated 13-09-2021 that the terms and conditions of the tender and the agreement executed by firm will be applicable.

Thus Firm D.R. Paint And Chemicals has violated the tender clause No. 13 (i) " If two batches of any drug supplied by a company/Firm is found "Not of Standard Quality" ,then the Supplier Company/Firm shall be blacklisted for that particular drug for a period of three year" by supplying Eight "Not of Standard Quality" drug batches, batch no RO/0921/003, RO/0921/006, RO/0921/007, RO/0921/008, RO/0921/010, RO/0921/013, RO/0921/022 and RO/0921/025 of Drug "Alcohol Based Hand Sanitizer" to different District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. Hence, the Firm D.R. Paint And Chemicals is, hereby, blacklisted for the drug "Alcohol Based Hand Sanitizer" for three years from the date of issue of this Office order.


