ANG lifesciences India Ltd has supplied "Amoxicillin Trihydrate with Clavulanate Potassium Inj. 1.2gm Dry Powder vial batch no AB192039 and batch no AB192054 to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. against purchase order no. UP/UP/HQ/21/1100/1(10282106700), dated 02.12.2021.

A notice (UPMSCL/MD/QC/2022/1061 dated 06.10.2022) was sent to Company on dated 06.10.2022 for supplying "Not Of Standard quality" drug "Amoxicillin Trihydrate with Clavulanate Potassium Inj. 1.2gm Dry Powder Vial batch no AB192054. Response (Ref.No- ANG/22-23/559 dated- 13.10.2022) from ANG lifesciences India Ltd obtained via e-mail on dated 17.10.2022. Response from ANG lifesciences India Ltd was taken in to consideration but not found justifiable.

Another notice (UPMSCL/MD/QC/2023/1729 dated 05.01.2023) was sent to ANG lifesciences India Ltd on dated 05.01.2023 for supplying "Not Of Standard quality" drug "Amoxicillin Trihydrate with Clavulanate Potassium Inj. 1.2gm Dry Powder Vial batch no AB192039. ANG lifesciences India Ltd. has not provided any response of notice dated 05.01.2023 till date.

With reference to above it is clear that ANG lifesciences India Ltd has supplied Two "Not Of Standard Quality" drug batches i.e. batch no. AB192039 and AB192054 against purchase order no. UP/UP/HQ/21/1100/1(10282106700), dated 02.12.2021. "Not Of Standard Quality" reports declared by Government Analyst and UPMSCL empanelled laboratories has neither been cancelled nor annulled by any higher authority and therefore the Government Analyst and UPMSCL empanelled laboratories report remains conclusive report till date. Thus ANG lifesciences India Ltd has violated the tender clause No. 13 (i) of tender no. UPMSCL/Drugs-027/120 dated 08.08.2019 i.e. " if two batches of any drug supplied by the supplier is found not of standard quality, then the supplier shall be blacklisted for that particular drug for the period of 3 (Three) Years" by supplying two "Not of Standard Quality" drug batches i.e. batch no. AB192039 and AB192054 of drug Amoxicillin Trihydrate with Clavulanate Potassium Inj. 1.2 gm Dry Powder vial to different district drug warehouse of Uttar Pradesh Medical Supplies Corporation Limited. Hence, ANG lifesciences India Ltd is, hereby, blacklisted for the drug "Amoxicillin Trihydrate with Clavulanate Potassium Inj. 1.2 gm Dry Powder vial" for three years from the date of issue of this order.


