ANG Lifesciences India Ltd has rate contract with this Corporation for the supply of drug "Amoxycillin Trihydrate With Clavulanate Potassium : - 500mg+100mg : dry powder Injection". ANG Lifesciences India Ltd have supplied "Amoxycilline Trihydrate With Clavulanate Potassium : - 500mg+100mg : dry powder Injection" to various district drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. against Purchase order no. UP/UP/HQ/19/271/1 (10281905759) dated 26.3.2019, Purchase order no. UP/UP/HQ/21/618/1 (10282104100) dated 14.7.2021 and Purchase order no. UP/UP/HQ/21/964/1 (10282105902) dated 13.10.2021.

A notice (Ref-UPMSCL/QC/2019/14003 Dated- 19 October 2019) for "Not of Standard Quality" drug batch AB339008 declared from Govt. Analyst U.P FDA of drug "Amoxycillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection " was sent to firm ANG Lifesciences India Ltd on dated 19.10.2019. In representation dated 24.10.2019 which was received to UPMSCL on 07.11.19 and representation dated 19.11.2019 which was received to UPMSCL on 26.11.2019, ANG Lifesciences India Ltd has requested to provide details of all material lying of drug Amoxycillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection batch AB339008 at different health facilities of UP and warehouses of UPMSCL which was provided by UPMSCL via e-mail on dated 20.11.2019.

Another notice (Ref-UPMSCL/MD/QC/2022/164 dated 30.04.2022) for "Not of Standard Quality" drug batch AB331005 declared from Government Analyst U.P FDA of drug "Amoxycillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection " was sent to ANG Lifesciences India Ltd on dated 30.04.2022. ANG Lifesciences India Ltd has provided response via letter dated 05.05.2022, 09.05.2022 and 11.05.2022 to notice dated 30.04.2022. In representation dated 05.05.2022 (Ref. no. ANG/22/13 dated 05.05.2022, received to UPMSCL on 25.05.2022), ANG Lifesciences India Ltd has requested to send drug batch sample for re-testing to CDL Kolkata. In representation dated 09.05.2022 (Ref. no. ANG/22/13 dated 09.05.2022, received to UPMSCL on 12.05.2022), ANG Lifesciences India Ltd has written that the company will be invoking the section 25 (4) of the Drug and Cosmetic act to challenge the report bearing no. V/715-22 dated 26.03.2022 of the Government Analyst within 28 days as per the provision. In representation dated 11.05.2022 , ANG Lifesciences India Ltd has written that Company has challenged the test report of public Analyst bearing no. V/715-22 dated 26.03.2022 by invoking the section 25 (4) of the Drug and Cosmetic act. In representation dated 11.05.2022, ANG Lifesciences India Ltd has attached a copy of letter (Ref. no. ANG/22/015 dated 10.05.2022) sent by Company to Drug Inspector FDA Sultanpur in which Company has requestd to send drug batch AB331005 sample to Central Drug Laboratory Kolkata. Apart from letter to Drug Inspector, no other document or conclusive evidence was provided by the ANG Lifesciences India Ltd regarding challenging the Government Analyst report (Certificate no. V/715-22 dated 26.03.2022) till date.

One more drug batch no. AB331034 of drug "Amoxycillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection " declared "Not of Standard Quality" from FDA,UP was supplied by the ANG Lifesciences India Ltd on Purchase order no. UP/UP/HQ/21/964/1(10282105902), dated 13.10.2021. Notice (Ref no UPMSCL/MD/QC/2023/1767 dated-12.01.2023) was sent to firm on dated 12.01.2023. In representation dated 20.01.2023, Company has requested to give time up to 25.01.2023 for the

submission of reply to notice dated 12.01.2023. Further ANG Lifesciences India Ltd has not provided any response to UPMSCS notice dated 12.01.2023.

In above case final report is "Not of standard quality" on the basis of three Not Of Standard Quality reports of drug Batches AB339008, AB331005 and AB331034 of the drug "Amoxicillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection" . ANG Lifesciences India Ltd has challenged the Government Analyst report (Certificate no. V/715-22 dated 26.03.2022) of drug batch AB331005 through Drug Inspector FDA Sultanpur but other two drug batches AB339008 and AB331034 which were declared "Not Of Standard Quality" by Government Analyst has neither been cancelled nor annulled by any higher authority and therefore the Government Analyst report remains conclusive report till date Thus Firm ANG Lifesciences India Ltd has violated the tender (Tender No. UPMSCS/Drugs-002/261 dated 29.05.2018 and Tender No. UPMSCS/Drugs-053/212 dated 15.06.2020) clause No. 13 (i) "If two batches of any drug supplied by the supplier is found not of standard quality, then the supplier shall be blacklisted for that particular drug for the period of 3 (Three) Years" by supplying Not of Standard Quality drug batches of drug "Amoxicillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection to different district drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. and health facilities of Uttar Pradesh. Hence, the Firm ANG Lifesciences India Ltd is, hereby, blacklisted for the drug Amoxicillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : Dry powder Injection for three years from the date of issue of this order.

In representation dated 20.01.2023, Company has requested to give time up to 25.01.2023 for the

submission of reply to notice dated 12.01.2023. Further ANG Lifesciences India Ltd has not provided any response to UPMSCS notice dated 12.01.2023.

In above case final report is "Not of standard quality" on the basis of three Not Of Standard Quality reports of drug Batches AB339008, AB331005 and AB331034 of the drug "Amoxycillin Trihydrate with Clavulanate Potassium :- 500mg+100mg : dry powder Injection" . ANG Lifesciences India Ltd has challenged the Government Analyst report (Certificate no.
