#### # Specifications of PPE Coverall breathable fabric for COVID-19 with Shoe cover:

- 1. Single use coverall for use by health care professionals.
- 2. White/light shades to better detect possible contamination.
- 3. Full body coverall from head to toe or Full body coverall from head to ankle with wrist and ankle ribs with separate above ankle foot cover with rib.
- 4. Coverall shall be available in different sizes(L,XL,XXL&XXXL). Availability of size L should be 50% & XL 40% and XXL & XXXL 10 %.
- 5. Design should allow easy donning and safe doffing, and **should be comfortable to wear**.
- 6. Coverall should have inbuilt hood cap.
- 7. Zero error lockable zipper (**metallic or non-metallic**) of the coverall should be in the front and should be covered with a broad flap to completely cover the zipper.
- 8. Soft Elastic should be fitted around Front of hood, wrists and ankles.
- 9. Seams should be thermally sealed or taped.
- 10. Full body coverall must be manufactured using breathable fabric. Polyethylene lamination is not accepted. If laminated, the lamination material must be breathable

Kits which have been tested for Moisture Vapor Transmission Rate following **ASTME 96** standard would be considered first for technical evaluation. Breathability parameters of the fabric should be Water/moisture vapour transmission rate-WVTR/MVTR: **minimum 400grams/m2/day**.

#### **Terms and Conditions:**

- 1. Copy of the valid license to manufacture/import the item from the Competent Authority.
- 2. Rate mentioned in table-1 is inclusive of all the charges like GST, transport.
- EMD for participation is 0.5% of procurement value i.e., Rs. 85,050, to be submitted through RTGS/NEFT (Account Holder Name: U P MEDICAL SUPPLIES CORPORATION LTD, Account No: 39366886265, Bank Name: State Bank of India, Branch- UP Civil Secretariat, Vidhan Sabha Marg, Lucknow, Uttar Pradesh, IFSC code: SBIN0006893).
- 4. Performance security will be 2% of the value of the goods purchased as stated in the Purchase Order. Performance security may be furnished in form of an Account Payee BG/NEFT/RTGS from a nationalized/ scheduled bank approved by RBI. Performance security should remain valid for a period of 05 months from the date of completion of supply. Performance security has to be submitted by each successful manufacturer without any exception.
- 5. The supplies have to be initiated within 7 days of release of purchase order & completed within 20 days. Supplies can be received up to 30<sup>th</sup> day with 0.2% LD charge per day on value of the goods supplied with delay. The PO is subject to be cancelled if not supplied in the speculated time.
- 6. The batch size of kit should be of 5000 kits. Random sample from each batch will be tested for quality by Govt. authorized Laboratory. And those lots which declared PASS by the quality control department UPMSCL will be accepted. The testing charges are to be borne by the supplier of the coverall. There will be no chance of replacement for quality non compliant batches. Also such non compliant batches is to be taken back by the supplier at their own expenses.
